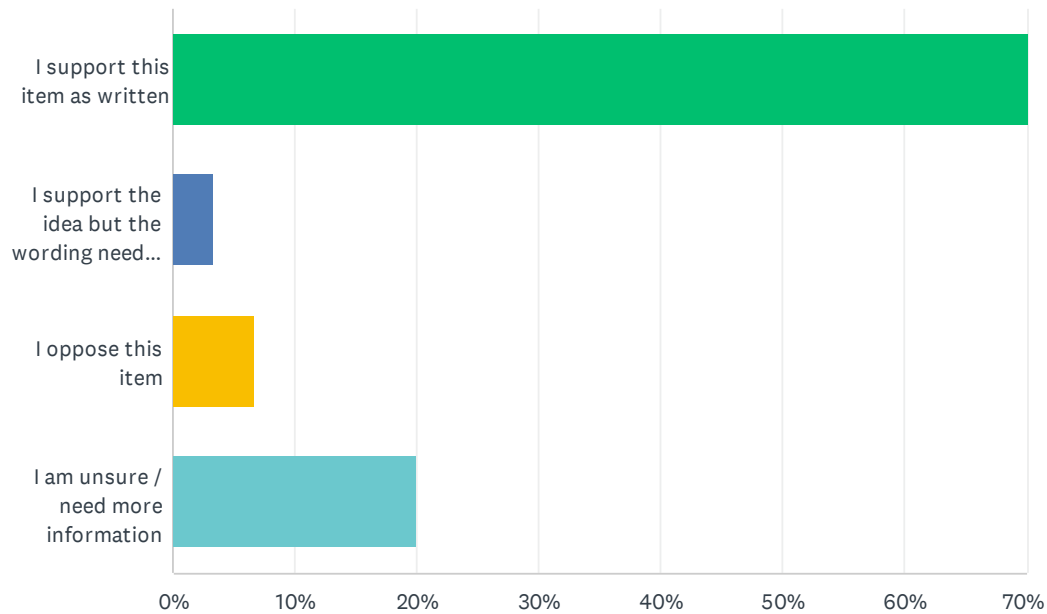

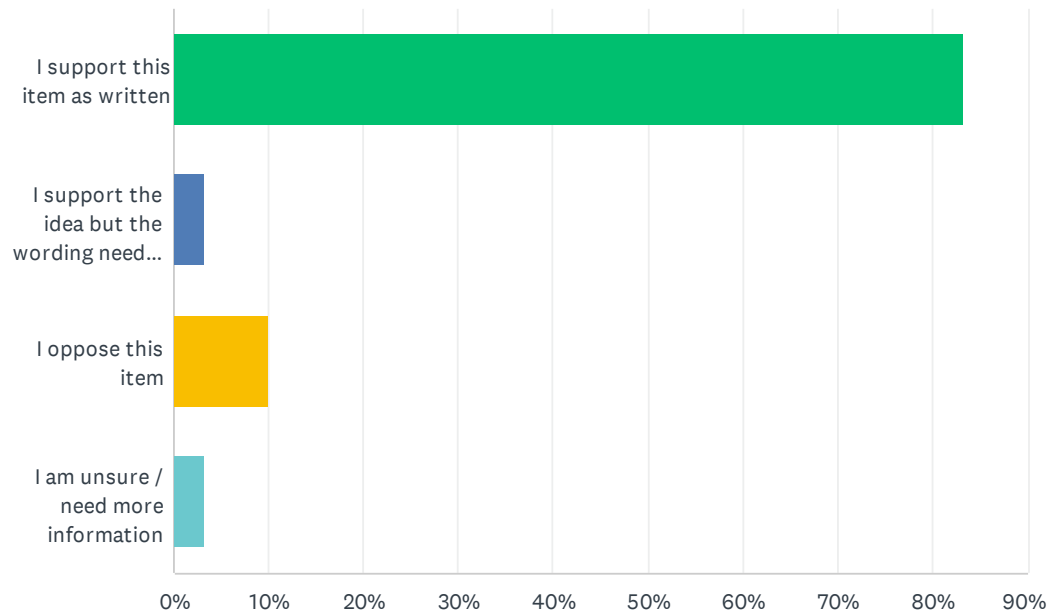

Q2 Voting Rights Change

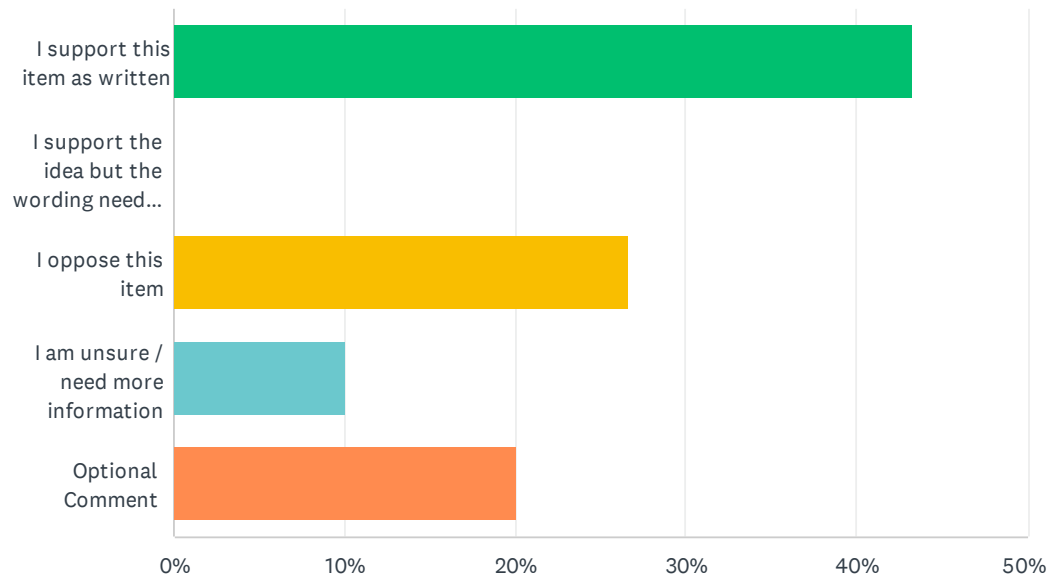

Q3 Assessment Structure Change

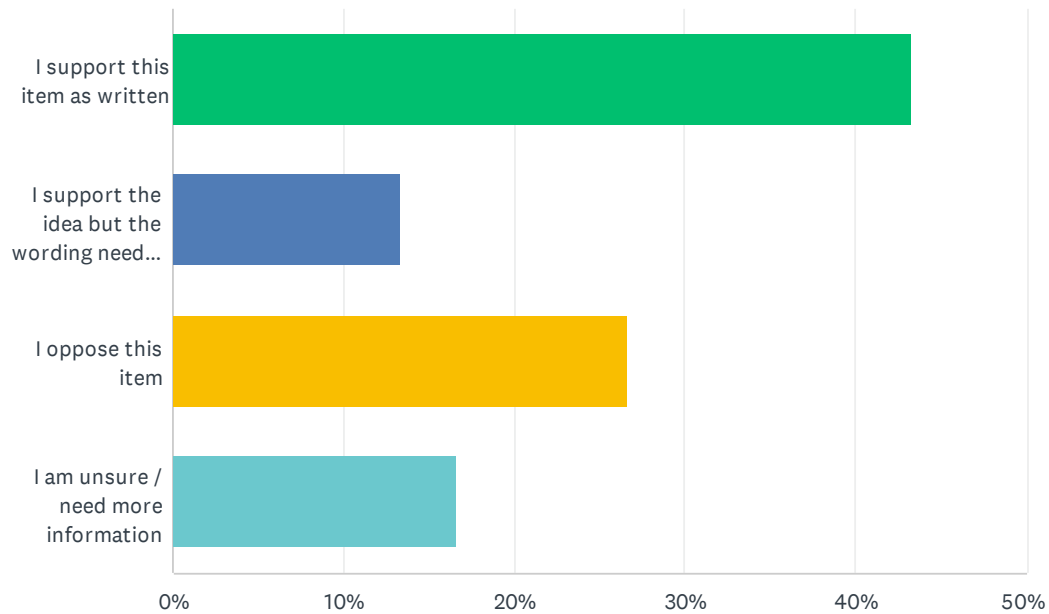

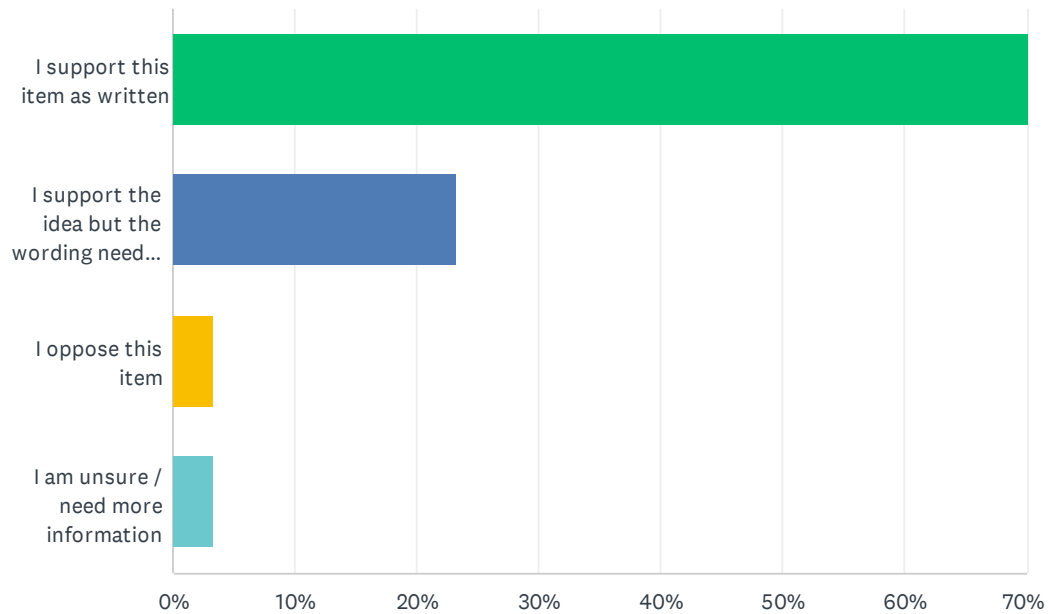

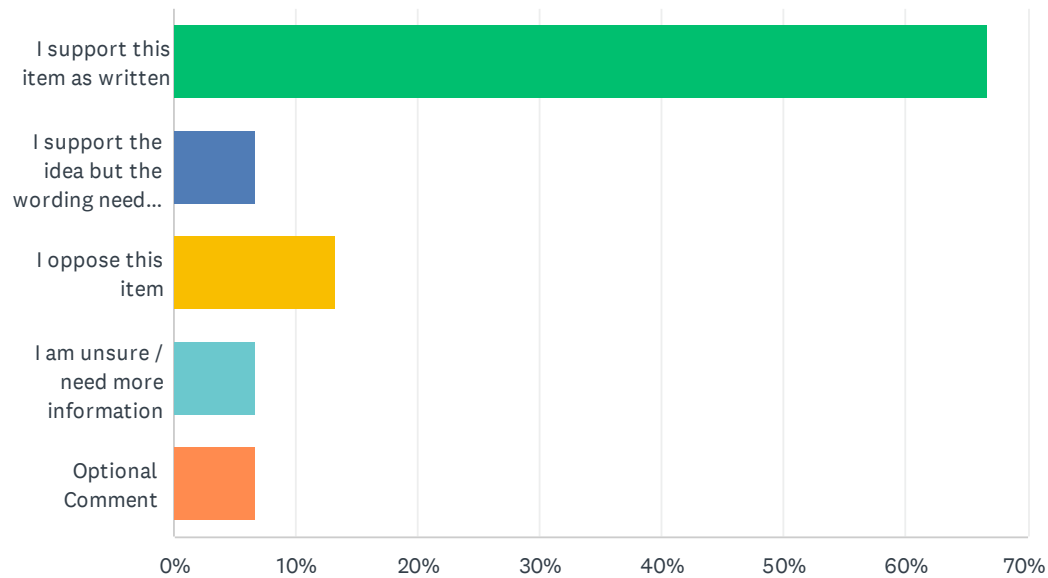

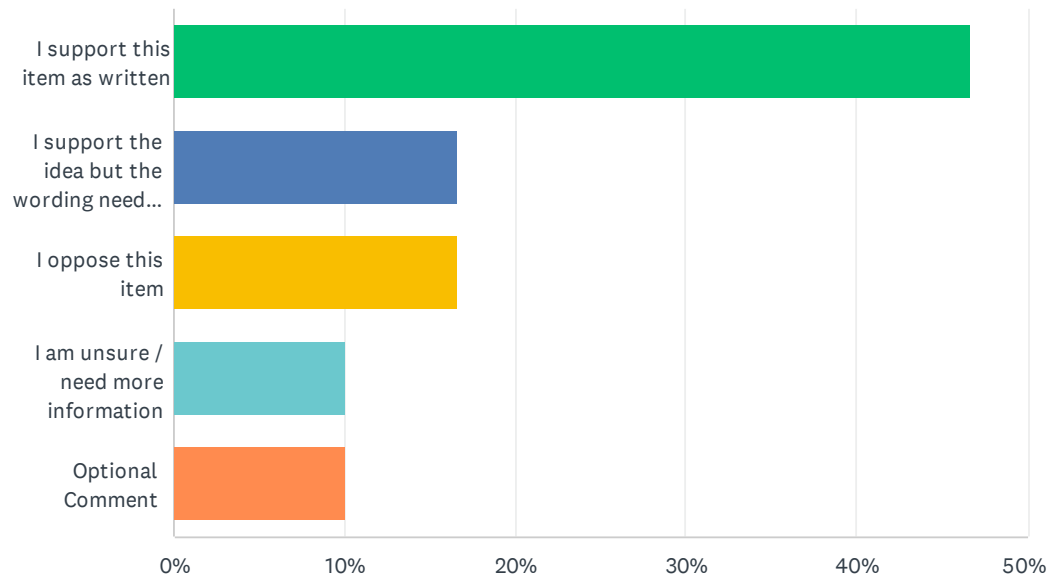

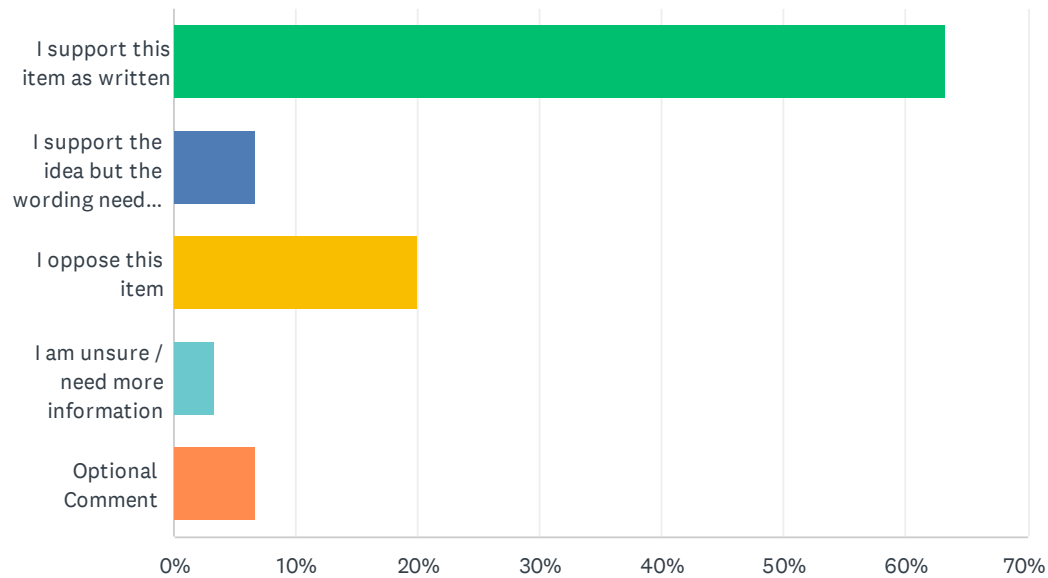

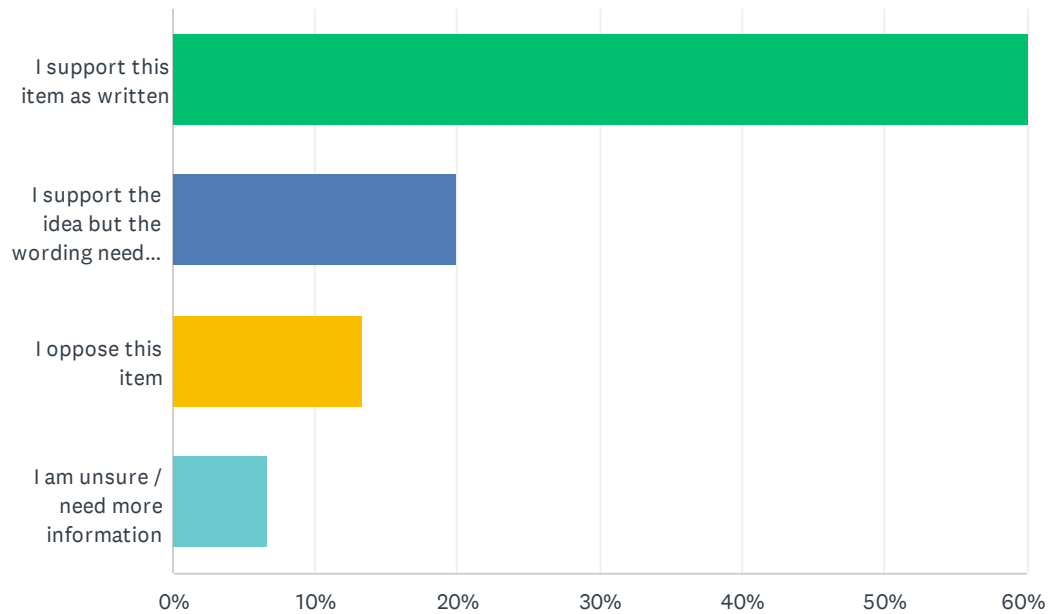

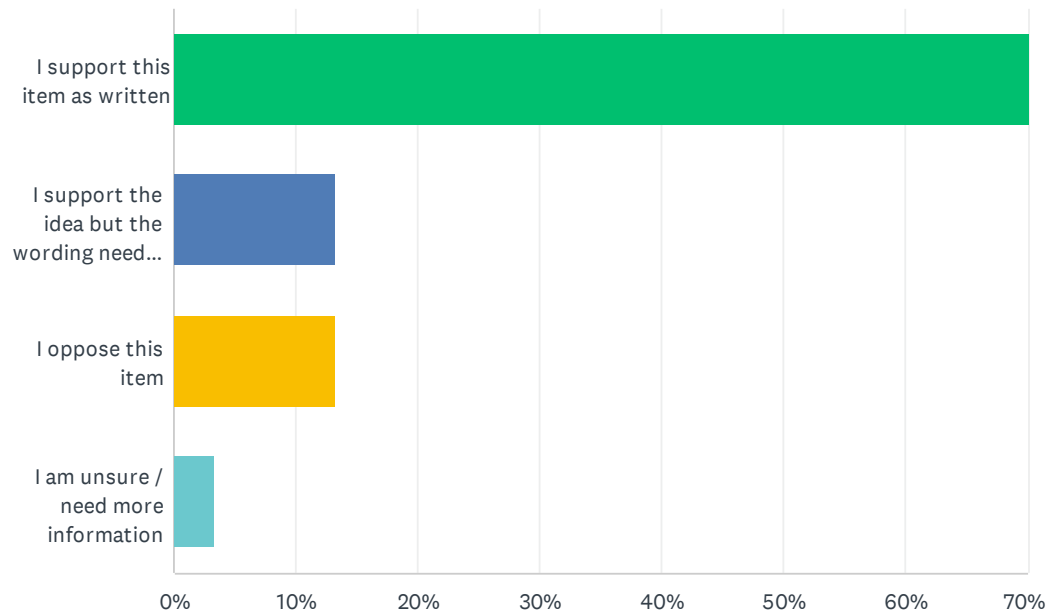

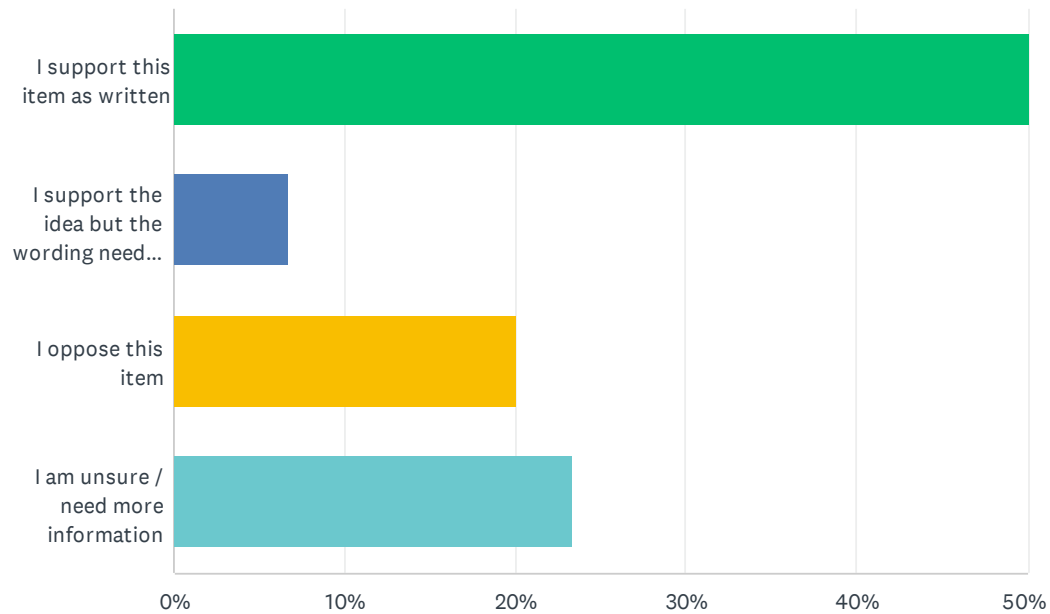

Q14 ACC Structure & Authority

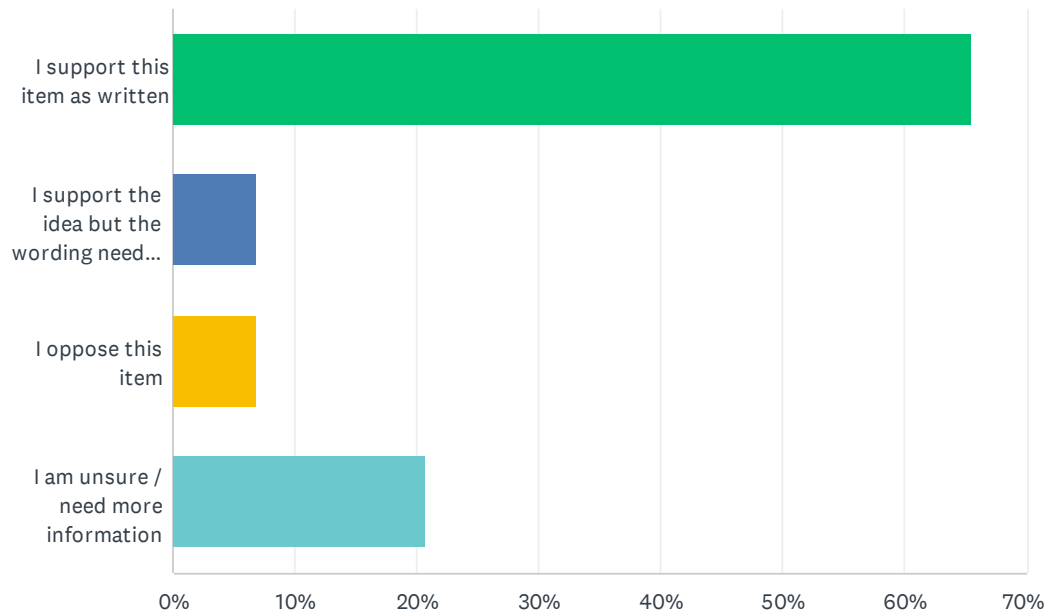

Q15 Amendment Procedure Simplification

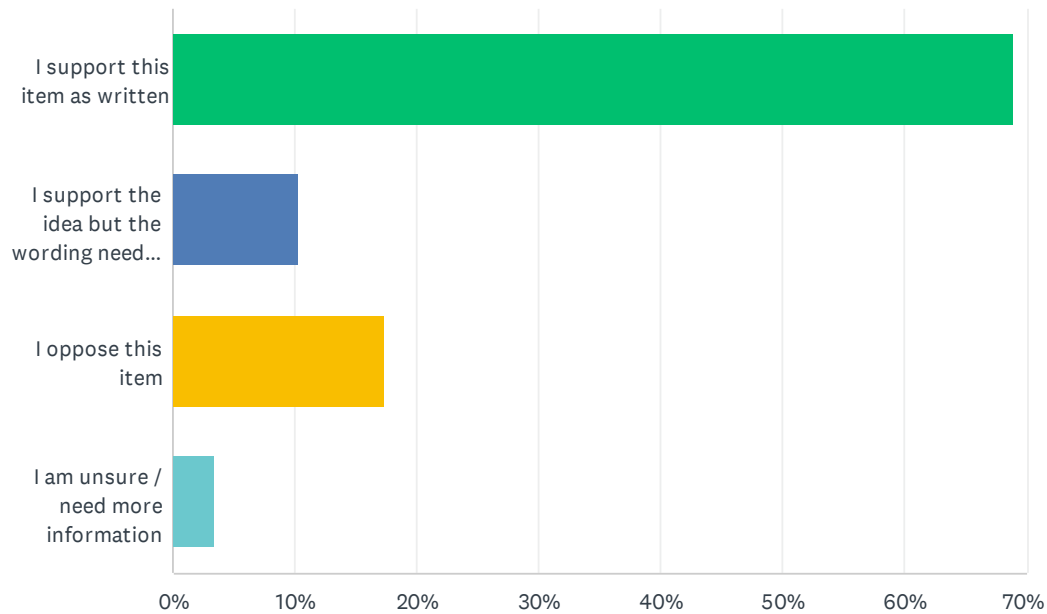

Q16 Mediation Requirement

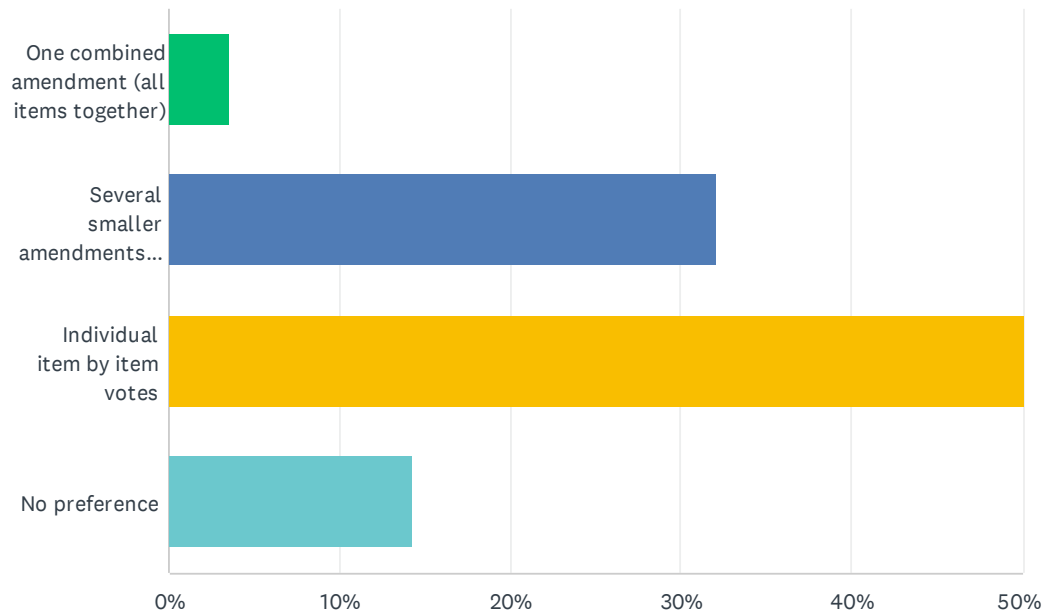

Q17 How would you prefer future CCR amendments be voted on?

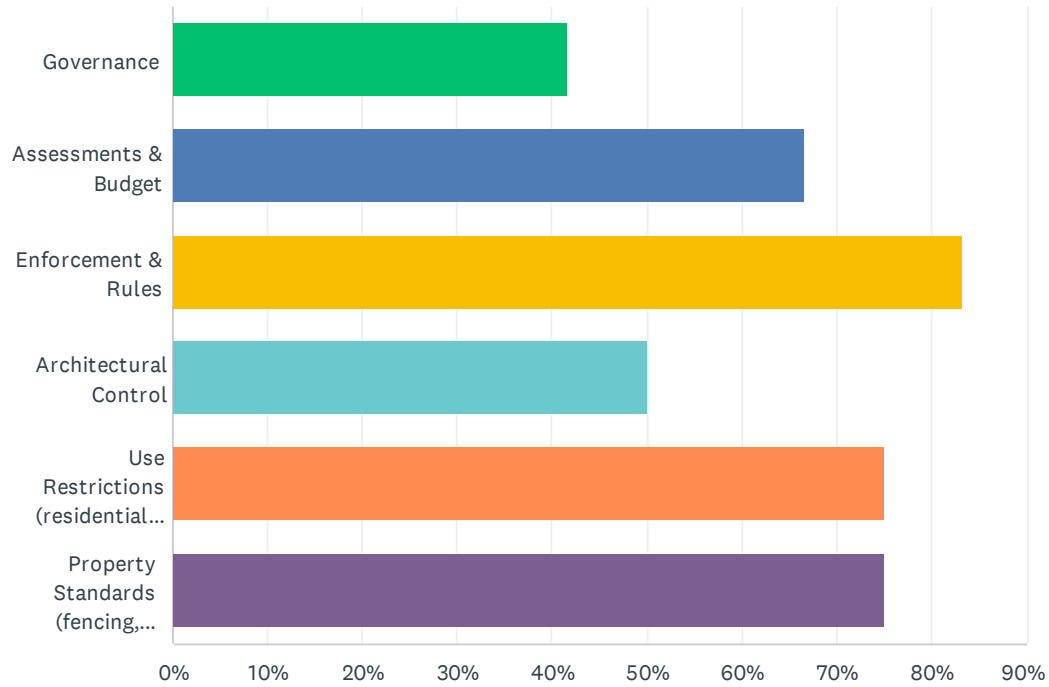
